## Low Severity Issues and Owner privileges

### 1. Zero address checking

Issue:

There is no zero address checking in functions [\\_transfer](#), [\\_transfer](#), .

Recommendation:

Please add zero address checking:

```
require(recipient != address(0));
```

### 2. Block gas limit

Issue:

The [massUpdatePools](#) function can fail due to block gas limit if the pool size is too big.

### 3. [add](#) function issue

Issue:

If some LP token is added to the contract twice using function `add`, then the total amount of reward `NATIVEReward` in function `updatePool` will be incorrect.

Recommendation:

Add the mapping from address to bool and check that same address will not be added twice.

# Conclusion

Smart contracts do not contain any high severity issues! Audited only the listed above six contracts, without any other contracts of this project.
